Eligibility Criteria for Candidates:

Any individual residing within the SWCC catchment area is eligible to run for a position on the Board of Directors. Candidates must submit their nomination details (name and address) and a brief statement (250 words) outlining their qualifications and vision for SWCC to agm@swcc1.ca. Candidates will have to show acceptable proof of residing in the catchment area. Nominations must be received no later than Sep 20, 2024.

Eligibility to vote at the AGM:

All residents living within the SWCC catchment area are eligible to vote in the board elections.

Acceptable proof of residing in catchment area (for candidates and voters)

- A government issued photo ID (E.g. Driver's License) that shows the address and postal code.
- A combination of government issued photo ID and other identification showing the address and postal code (Utility bills, health card, lease documents etc.)
